

Virginia Association for Career & Technical Education Bill Report

January 23, 2026

As the 2026 Virginia General Assembly advances through the heart of its 60-day session, several major themes are shaping the work in both chambers. With Democrats holding unified control of the House, Senate, and the Governor's Office under Governor Abigail Spanberger, the legislature is actively pursuing an economic agenda that encompasses issues pertaining to healthcare, childcare, housing policy, and energy initiatives that reflect broader state and national economic pressures. State leaders have emphasized lowering costs while also pursuing investments in infrastructure modernization.

Governor Spanberger's administration has been especially active this year, making several high-profile appointments and policy pushes that are influencing the Assembly's work. In the opening weeks of her term, Spanberger appointed 27 new members to boards governing state universities, including the University of Virginia, George Mason University, and Virginia Military Institute, following the resignation of several members at her request. Spanberger also delivered a policy address to the General Assembly emphasizing priorities like expanding paid family leave, raising the minimum wage, and addressing housing concerns, setting the tone for the legislative session.

Budget negotiations and deadlines remain central to the session's calendar. Virginia lawmakers are working within well-established procedural milestones: committees such as the House Appropriations Committee and Senate Finance and Appropriations Committee are scheduled to complete action on their respective budget drafts in early February, with crossover deadlines and final budget action approaching shortly thereafter. The General Assembly's key fiscal deadlines include committee completion on the budget by February 22 and the scheduled sine die adjournment on March 14, followed by a reconvened session on April 22 to consider gubernatorial amendments and vetoes. Action on the budget is especially consequential this year given the biennial budget cycle for the 2026–2028 biennium and the need to reconcile House and Senate priorities with the governor's proposals.

Policy committees across the General Assembly have also been busy. Appropriations and other key panels have held hearings and begun reporting measures forward. For example, the House Appropriations Committee's agenda reflects consideration of major funding components and constitutional amendments tied to broader legislative priorities. Meanwhile, other committees are advancing bills tied to the legislature's focus on affordability, transportation, workforce development, and public safety.

In addition to the work on the budget and policy bills, lawmakers are preparing for crossover — the critical point by February 17 after which a chamber cannot act on its own originating legislation if it has not passed the opposite chamber. This timeline is prompting leadership to move key measures quickly through committee and floor action to ensure they remain viable. As the session progresses toward these deadlines, observers expect continued momentum on high-profile legislation, negotiations on appropriations, and potential clashes over amendments and policy substance in the context of the Democratic trifecta's agenda.
